#### THE CITY OF FLIN FLON

### **BY-LAW NO. 2020-14**

Being a By-Law of The City of Flin Flon to establish and Re-dedicate the land and locations of four Public Cemeteries.

PASSED: November 17, 2020

WHEREAS there have been four public cemeteries dedicated within the City of Flin Flon, and

WHEREAS it is deemed appropriate at this time to re-dedicate the said lands, and

WHEREAS this By-Law is authorized under the provisions of The Municipal Act, S.M. 1996, c. 58, Chap. M225, now

THEREFORE the Council of The City of Flin Flon, in Council duly assembled, enacts as follows:

1. The following properties are hereby re-dedicated and reserved to be used as public cemeteries and for no other purpose.

### a) HILLSIDE CEMETERY

All that portion of the Northwest quarter of Section Thirty-one, in Township Sixty-six, and Range Twenty-nine, west of the Principal Meridian, in Manitoba, shown bordered red and designated Parcel "D" on a Plan of Survey registered in the Neepawa Land Titles Office as No. 4441 shall be known as Hillside Cemetery.

### b) ROSS PARK CEMETERY

All that portion of the Southeast quarter of Section Six, in Township Sixty-seven, and Range Twenty-nine, west of the Principal Meridian, in Manitoba, designated Block "C" on a Plan of Survey registered in the Neepawa Land Titles Office as No. 609 shall be known as Ross Park Cemetery.

# c) **SOUTH MAIN CEMETERY**

All that portion of Lot Two, Block Four Hundred and Sixteen, shown on a Plan of Survey registered in the Prince Albert Land Titles Office as No. C.W. 5336, described as follows:

Beginning at the Southeast corner of said lot, then northerly along the Eastern Boundary of said lot a distance of sixty-nine feet, thence westerly at right angles to lastly above described course a distance of forty-five feet, thence southerly at right angles to the lastly above described course, to the Southern Boundary of said lot, thence easterly along the said Southern Boundary to the point of commencement and shall be known as <u>South Main Cemetery</u>.

## d) **EAST HILLSIDE CEMETERY**

All that portion of the West ½ of Section Thirty-one, in Township Sixty-six, and Range Twenty-nine, west of the Principal Meridian, in Manitoba, and designated as Plan 4400 N.L.T.O. and shall be known as <u>East Hillside Cemetery</u>.

### 2. **SOLDIER BURIALS**

- a) The Canadian Legion, B.E.S.L., Branch No. 73, shall be entitled to keep separate and maintain a special portion within the cemeteries, to be known as the "Legion Section".
- b) Markers in these sections must meet the requirements of The Canadian Legion B.E.S.L., Branch No. 73, which is a D.V.A. lawn level marker.

- 3. The <u>Social and Community Services Committee</u> shall be responsible for setting policy and regulations governing the cemetery operations.
- 4. The Cemetery Superintendent and/or any other person delegated to act on behalf of the Cemetery Superintendent by Council, shall be responsible for the day to day maintenance of the cemeteries.
- 5. This bylaw shall come into effect
- 6. Bylaw 25/2000 is hereby repealed.
